A 35-YEAR-OLD man was arrested in Banaskantha for allegedly murdering his mother in a fit of rage when she refused to give him money.

According to police, Bharaf Shri Ram Brahmin (35), a resident of Bhachali village under Vav Taftika of Banaskantha, allegedly stabbed his mother Naviben Brahmin (58) to death at his residence on Saturday. The accused had fled the village after the incident.
